SEATTLE HOUSE PROVIDES SUPPORTIVE, TEMPORARY LODGING TO FAMILIES OF  
SERIOUSLY ILL CHILDREN WHO MUST LEAVE THEIR OWN COMMUNITY TO HAVE THEIR  
CHILDREN TREATED AT SEATTLE CHILDREN'S HOSPITAL. IN 2020, 250 FAMILIES  
STAYED AT THE SEATTLE HOUSE. BY PROVIDING A "HOME-AWAY-FROM-HOME," RMHC  
HELPS KEEP FAMILIES TOGETHER DURING A VERY DIFFICULT TIME IN THEIR  
LIVES.
