Ronald McDonald House Charities of Washington & Alaska (RMHC) supportive, temporary lodging to families of seriously ill children who must leave their own community to have their children treated at Seattle Children's hospital. In 2024, 578 families stayed at the Seattle House 35,385 nights of housing and services provided. The RMHC also operates a house in Anchorage, Alaska, in partnership with average length of stay was 49 days. By providing a home-away-from-home, RMHC helps keep families together during a very difficult time in their lives.

The Alaska House, the 34-room house is within the Alaska Native Medical Center (ANMC) patient housing building and serves expectant mothers with high-risk pregnancies as well as families of pediatric patients. In 2024, 1,577 families were served at ANMC with 10,156 nights of housing and services provided. The average length of stay was 6 days.
